**EAIC TO LOOK INTO SITI KASIM'S ARREST**

25 June 2018, Putrajaya - The Enforcement Agency Integrity Commission (EAIC) view with grave concern upon the allegation of police impropriety and the misuse of power pursuing the recent arrest of lawyer-activist Siti Kasim on 24 June 2018.

EAIC will be looking into the matter to determine whether the police had followed the SOP (Standard Operating Procedure) in effecting the arrest and hence whether there is any truth in the allegation of police impropriety in carrying out their duty and function.

This is in line with the provision in section 28 of the Enforcement Agency Integrity Commission 2009 [Act 700] whereby the Commission may commence its own investigation since the matter is of significant interest to the public.

25 Jun 2018, Putrajaya - Suruhanjaya Integriti Agenzi Penguatkuasaan (EAIC) memandang serius terhadap dakwaan ketidakpatuhan prosedur dan salah guna kuasa oleh pihak polis dalam penahanan peguam dan aktivis Siti Kasim pada 24 Jun 2018.

EAIC akan meneliti perkara ini dengan lebih lanjut sama ada penahanan tersebut adalah mengikut Prosedur Operasi Standard (SOP) oleh pihak polis dan sama ada terdapat sebarang ketidakpatuhan dalam menjalankan tugas dan fungsi mereka.

Ini adalah selaras dengan peruntukan dalam seksyen 28 Akta Suruhanjaya Integriti Agenzi Penguatkuasaan 2009 [Akta 700] di mana Suruhanjaya boleh memulakan siasatannya berdasarkan kes-kes yang melibatkan kepentingan orang awam.
