(PINDAAN JADUAL) 2023**

PADA menjalankan kuasa yang diberikan oleh seksyen 55 Akta Suruhanjaya Integriti Agensi Penguatkuasaan 2009 [Akta 700], Perdana Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Suruhanjaya Integriti Agensi Penguatkuasaan (Pindaan Jadual) 2023.**

(2) Subperenggan 2(a) dan (b) mula berkuat kuasa pada 8 September 2023.

(3) Subperenggan 2(c) disifatkan telah mula berkuat kuasa pada 1 Julai 2023.

**Pindaan Jadual**

2. Jadual kepada Akta Suruhanjaya Integriti Agensi Penguatkuasaan 2009 dipinda—

(a) dengan menggantikan butiran “Kementerian Perdagangan Dalam Negeri dan Hal Ehwal Pengguna (Bahagian Penguatkuasaan)” dengan butiran “Kementerian Perdagangan Dalam Negeri dan Kos Sara Hidup (Bahagian Penguatkuasaan)”;

(b) dengan menggantikan butiran “Kementerian Perumahan dan Kerajaan Tempatan (Bahagian Penguatkuasaan)” dengan butiran “Kementerian Pembangunan Kerajaan Tempatan (Bahagian Penguatkuasaan)”;

(c) dengan memotong butiran “Polis Diraja Malaysia”.

ENFORCEMENT AGENCY INTEGRITY COMMISSION ACT 2009

ENFORCEMENT AGENCY INTEGRITY COMMISSION  
(AMENDMENT OF SCHEDULE) ORDER 2023

IN exercise of the powers conferred by section 55 of the Enforcement Agency Integrity Commission Act 2009, the Prime Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Enforcement Agency Integrity Commission (Amendment of Schedule) Order 2023**.

(2) Subparagraphs 2(a) and (b) come into operation on 8 September 2023.

(3) Subparagraph 2(c) is deemed to have come into operation on 1 July 2023.

**Amendment of Schedule**

2. The Schedule to the Enforcement Agency Integrity Commission Act 2009 is amended—

(a) by substituting for the item “Ministry of Domestic Trades and Consumer Affairs (Enforcement Division)” the item “Ministry of Domestic Trade and Cost of Living (Enforcement Division)”;

(b) by substituting for the item “Ministry of Housing and Local Government (Enforcement Division)” the item “Ministry of Local Government Development (Enforcement Division)”; and

(c) by deleting the item “Royal Malaysia Police”.
