### **MOHAMAD ONN APPOINTED AS NEW CEO / SECRETARY OF EAIC**

Putrajaya 3 May 2018 - EAIC wishes to announce that, in line with Section 13 (1) of the Enforcement Agency Integrity Commission Act 2009 [Act 700], the Commission has appointed Encik Mohamad Onn bin Abd. Aziz as the Chief Executive Officer (CEO) / Secretary of the EAIC effective from 2 May 2018.

Prior to this appointment, Encik Mohamad Onn was the Senior Federal Counsel in the Advisory Division of Attorney General's Chamber Malaysia. He has also served the Business Support and Legal Services at the Malaysia - Thailand Joint Authority Management, the Ministry Of Higher Education and the Ministry of Transport Malaysia.

Encik Mohamad Onn is on secondment for period of two years and replacing Encik Ahmad Razif Mohd Sidek whose secondment at EAIC has ended and has since return to Attorney-General's Chamber effective from 1 March 2018.
